DISTRIBUTION LICENSE AGREEMENT

1. **GRANT OF LICENSE.** Subject to all of the terms and conditions of this license, Symyx Software, Inc. ("SYMYX") grants to the entity identified below in the signature field ("Distributor") a non-exclusive, non-transferable, limited license to download from SYMYX's Internet Web site the then currently available version of the SYMYX software programs checked below, along with the installer (together the "Software"), in binary executable form, for the express purpose of copying the Software in the form downloaded (i.e. uninstalled) onto CD-ROMs, at Distributor's sole expense, for distribution to Distributor's end users (for use under the terms and conditions of the Software(s) End User License Agreement incorporated in the installer) as provided herein.
